If membership terminates for any reason, Member agrees to return all such material and refrain from using Sayner-Star Lake-Cloverland Chamber name and logo in any of Member's promotional advertising.
3. This agreement shall remain in effect until terminated by Member or Sayner-Star Lake-Cloverland Chamber according to the bylaws.
4. Sayner-Star Lake-Cloverland Chamber Membership is not tax deductible as a charitable contribution but is deductible as a business expense.
